**Rules, Schedule and Clarifications**

- September 24<sup>th</sup>: Crescent Colts v/s Oakville B @ Mohawk Park(SF1)
  - September 24<sup>th</sup>: Stoney Creek S.A. v/s Hamilton B @ Churchill Park(SF2)
  - September 25<sup>th</sup>: Hamilton Cricket Club v/s Burlington U.C.C. @ Churchill Park (QF1)
  - September 25<sup>th</sup>: Crescent Cricket Club v/s Oakville C.C. @ Mohawk Park (QF2)
  - October 1<sup>st</sup>: Second Division: SF1 winner v/s SF2 winner at TBA
  - October 2<sup>nd</sup>: Mississauga Ramblers v/s QF2 winner at Mississauga (SF1)
  - October 2<sup>nd</sup>: Halton Warriors v/s QF1 winner at Burlington (SF2)
  - October 8<sup>th</sup>: Premier Final: SF1 v/s SF2 @ TBA
1. All play-offs games shall start at **11 am** with Toss to be taken at **10:45am**. Home teams are responsible to have the ground ready for play at 10:45.
  2. HDCL Official Match sheet must be completed with **Reg. Id** of only qualified players before taking the toss. Home teams to provide Match Sheet for games at their respective grounds.
  3. Only players that are deemed qualified to play in play-offs as per the HDCL league By-Laws (List to be emailed to all clubs before Wednesday 21<sup>st</sup>, 2011) shall feature on the match sheet. Any players not on qualified players' list shall not take part in any games and neither a request to be made to any opposing captain for such exception; any such player featuring in a game will result in automatic disqualification of such team from play-offs and opposing team will be declared winner.
  4. Results of each game must be communicated to league secretary by email at the earliest possible and official Match Sheet must be emailed to League Statistician latest by Monday evening following the game.
  5. Any team wishing to use a junior players in a play-off game, must provide a proof that the players is registered with that club and is under the age of 19 years on Sept 1<sup>st</sup>, 2011 and also has featured in minimum of one game for such club in regular season.
  6. Players who are qualified in 2<sup>nd</sup> division are automatically qualified to play for Premier Division teams provided such players have met qualification criteria in 2<sup>nd</sup> division for their respective clubs.
  7. Match referees will be appointed where possible to oversee players' conduct on and off the field as well as that of officiating umpires and will submit a written report of any incident to league executives within 4 hours of conclusion of any match.
  8. All matches will be played in accordance with the existing HDCL match play rules.
  9. No substitute to be allowed under any circumstances except for an on-field injury in the featured game.
  10. Any protest or dispute must be reported, in writing, within 4 hours of completion of any games.
  11. Each team to make its own arrangements for water and refreshments for all play-off games except finals.

1<sup>st</sup> Innings – 11am to 1:45pm (5 extra minutes allowed)  
30 minutes break  
2<sup>nd</sup> Innings – 2:15pm to 5:00pm (5 extra minutes allowed)

### **Other Notes:**

- League will provide balls for all Semi-Finals and Finals.
- League will provide one umpire for Quarter-finals and Semi-finals, teams to pay for other umpire.
- League will provide Balls, Umpires and Refreshments for Finals of both divisions.
- Winners and Runners up trophies to be presented at each final and rest of the presentation to take place at League Presentation Night on October 29<sup>th</sup>, 2011.
